NOTIFICATION

The Government of Karnataka has been successful in providing an effective investor facilitation for the investors to invest in Karnataka through the single window system. The single window system has been an effective mechanism where entrepreneurs have obtained the required clearances for setting up businesses in the State without having to visit multiple government departments.

Further, in order to make single window system more effective, and encourage the industry to use all the services for registrations & renewals through e-biz portal; it is mandated that all the applications are done **through online system only**. Further it is directed that henceforth all the applications pertaining to Project Approvals/ clearances/ registrations/ renewals/ etc. through Karnataka Udyog Mitra (Single Window Body) would be accepted through the online and no manual or hard copy submissions should be encouraged.

Further, in order to ensure effective service delivery through single window system and having synchronization with the line departments it is mandated that the timelines for the approvals/ clearances/ renewals/ etc. that are being followed **by each of the line departments, which are also included under Sakala** for the said services, would also be followed for the applications made through the e-Biz.
