Sub: Concession in processing fee for solar & Wind energy projects - reg.

Ref: GIM review meeting held on 24.9.2012

In the GIM review meeting held under the Chairmanship of Chief Secretary to Government on 24.9.2012, it was suggested to consider reducing the processing fee for Solar and Wind Energy projects. Accordingly, it has been decided to grant concession of 75% processing fee for Solar and Wind Energy projects received at KUM for SLSWCC & SHLCC approvals. This will be effect from 16.10.2012.

All the applications of Solar and Wind Energy projects received after 16.10.2012 shall be eligible for above concessions.

Further if the company needs only follow-up through E-Udyami portal, a nominal fee of Rs.10,000/- shall be collected.

Sub: Concession in processing fee for SC/ST entrepreneurs and GIM 2012 MOU, EOI & ROI projects – reg.

Ref: Proceedings of 43rd G.C meeting held on 26.9.2012

In the Governing Council meeting held on 26.9.2012, concession in processing fee for SC/ST entrepreneurs is extended as below with effect from 26.9.2012.

| v. | Projects above Rs. 1000 Crores upto Rs. 5000 Crores | - | Rs. | 15 Lakhs | 25% |
| vi. | Projects above Rs. 5000 Crores and above | - | Rs. | 30 Lakhs | 25% |

All the applications of SC/ST entrepreneurs received after 26.9.2011 shall be eligible for above concessions. In case of partnership and private limited, companies the stake of the SC/ST Directors/Partners in the firm/company should be more than 51% to obtain the above concessions.

Reduction in processing fee for GIM MOU, EOI & ROI projects: It was brought to notice of the G.C that no special discounts in concession fee or incentives of any sort is being offered for GIM 2012 MOU, EOI & ROI projects. In order to motivate these investors there is a need to give some discount in processing fee of KUM for GIM projects. After detailed discussions, the G.C approved to extend 25% concession in the processing fee of GIM MOU, EOI and ROI projects who will make application to KUM between 1.10.2012 to 31.12.2012.

In view of above, all the officers are hereby directed to collect the fees as above.
